

# NMB Aquatic & Fitness Center Party Information

# Party Details

- Purple Package (2 hours)
  - \* Includes 1 hour of play in the Swimming Pool.
  - \* Includes 1 hour of celebration in the Classroom.
  - \* An Activity Specialist will be available to assist during the party.
  - \* Member Fee: \$90.00 for up to 25 people, including adults and children.
  - \* Non-Member Fee: \$125.00 for up to 25 people, including adults and children.
  - \* The Waterslide is an additional \$50 fee.
- Teal Package (2 hours)
  - \* Includes 1 hour of play in the gymnasium.
  - \* Includes 1 hour of celebration in the Classroom.
  - \* An Activity Specialist will be available to assist during the party.
  - \* Member Fee: \$90.00 for up to 25 people, including adults and children.
  - \* Non-Member Fee: \$125.00 for up to 25 people, including adults and children.
- Orange Package (2.5 hours)
  - \* Includes  $1\frac{1}{2}$  2 hours of play divided between the pool and gymnasium.
  - \* Includes 1/2 to 1 hour of celebration in the Classroom.
  - \* An Activity Specialist will be available to assist during the party.
  - \*Member Fee: \$110.00 for up to 25 people, including adults and children.
  - \*Non-Member Fee: \$145.00 for up to 25 people, including adults and children.
  - \* The Waterslide is an additional \$50 fee.

### Adjustments to any of the above packages are as follows:

\* Additional people over 25: \$5.00 per person (child or adult)

#### Additional Information

- The NMB Aquatic & Fitness Center will provide party invitations that include a participation waiver. A parent or guardian for each child must complete and sign the waiver prior to the child participating in the Birthday Party. The child must bring the waiver to the party to be turned in to Aquatic & Fitness Center staff.
- In order to safely and appropriately staff the party, the NMB Aquatic & Fitness Center staff must know in advance how many people are expected to attend.
- A \$50.00 deposit is required at the time of the reservation to guarantee your date and time.

- 12:30-2:30 pm (Set-up no earlier than 12:00)
- 3:30-5:30 pm (Set-up no earlier than 3:00)

# **Party Policies**

- The birthday party rental does not include use of the entire facility.
- Members of the birthday party group must remain together at all times.
- There must be a minimum of one (1) adult per 8 children under the age of 17.
- Rules for all areas of the facility must be followed at all times during the party.
- You will have 30 minutes before your party is scheduled to set up.
- Decorations, food, and party items are the responsibility of the party group.
  Decorations may not be attached to any part of the building.
- Confetti or Silly String is not permitted.
- You will have 30 minutes after the party for clean up.
- Food or drink (other than water) is not permitted in any part of the building other than the classroom.
- The Aquatic & Fitness Center <u>does not</u> have a public kitchen, refrigerator, or freezer available.

#### **Pool Policies**

- Pool Parties will take place in the Therapy Pool.
- Certified lifeguards are on duty at all times.
- For children ages 6 and under, the adult to child ratio in the water is 1:5 (Example: 5 children= 1 adult in the water.) Please have parents prepared to swim to meet the set ratio.
- For the non-swimmer, a parent must be within arms reach of a child at all times.
- Prior to children entering the pool, the party will gather together so the lifeguard can explain the pool rules.
- Proper swim attire is required.
- Swim diapers are required for non-toilet trained children.

<sup>\*</sup> Other times may be available upon request. Birthday Parties are not available on Sundays.

# Cancellation Policy

- If a party is cancelled or rescheduled with at least 2-week notice, the NMB Aquatic & Fitness Center will fully refund the deposit.
- If a party is cancelled with less than 2 weeks notice the NMB Aquatic & Fitness Center will not refund the deposit.
