

NOTES TO USERS

This map is for use in administering the National Flood Insurance Program; it does not necessarily identify all areas subject to flooding, particularly from local drainage sources of small size, or all planimetric features outside Special Flood Hazard Areas. The community map repository should be consulted for possible updated flood hazard information prior to use of this map for property purchase or construction purposes.

Coastal base flood elevations apply only to areas of 0.0' National Geodetic Vertical Datum of 1929 (NGVD), and include the effects of wave action; these elevations may also differ significantly from those developed by the National Weather Service for hurricane evacuation planning.

Areas of special flood hazard (100-year flood) include Zones A, AE, AH, AO, AV9, V, and VE.

Certain areas not in Special Flood Hazard Areas may be protected by flood control structures.

Boundaries of the floodways were computed at cross sections and interpolated between cross sections. The floodways were based on hydraulic considerations with regard to requirements of the Federal Emergency Management Agency.

Floodway widths in some areas may be too narrow to show to scale. Floodway widths are provided in the Flood Insurance Study Report.

Corporate limits shown on this map are based on the best data available. The user should contact appropriate community officials to verify the corporate limit delineations shown on this map.

For community map revision history prior to countywide mapping, see section 6.0 of the Flood Insurance Study Report.

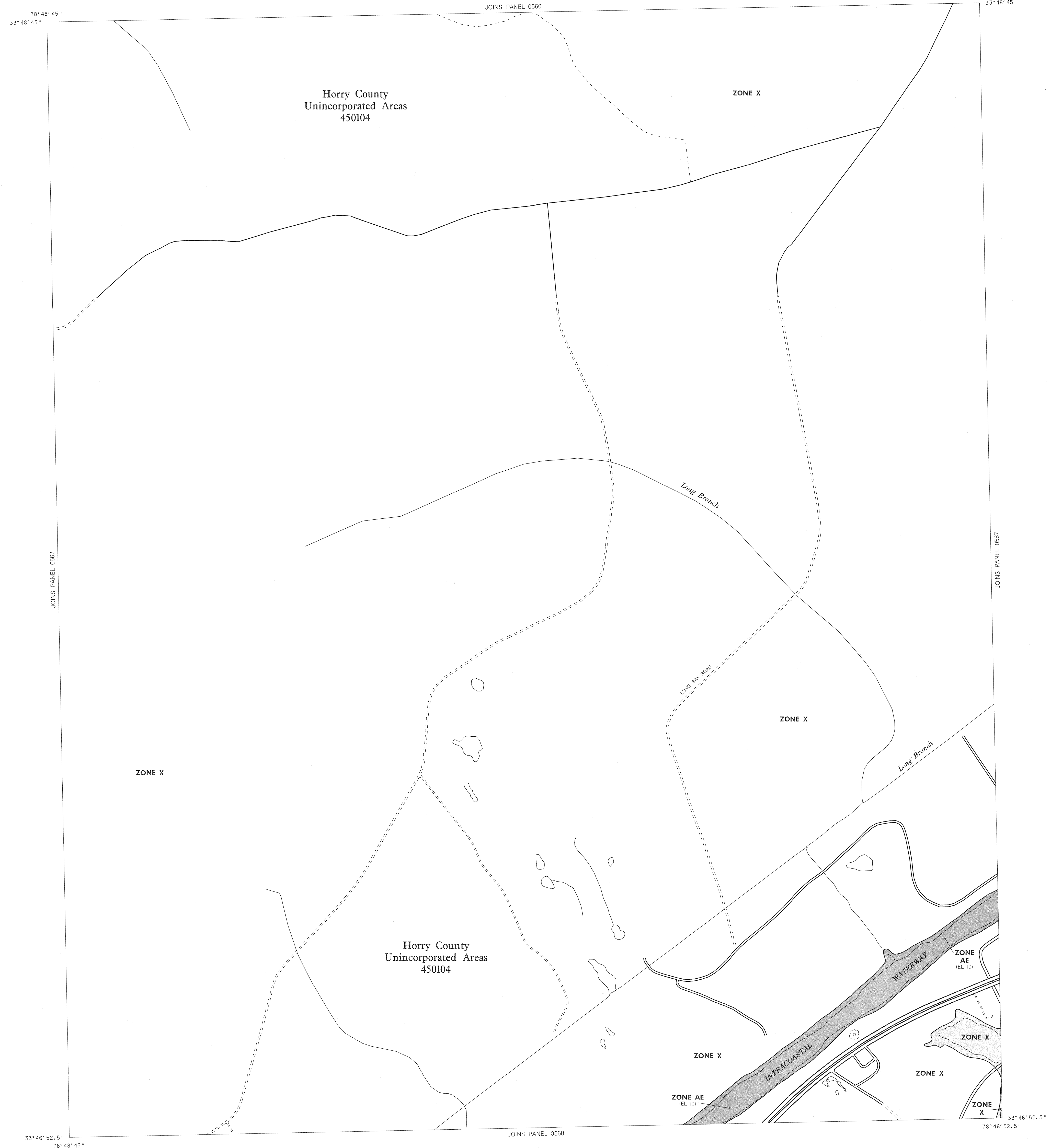
DIGITAL DATA AVAILABILITY: Digital files containing the thematic floodplain information shown on these maps are published by the Federal Emergency Management Agency in DUCO Digital format on CD-ROM. Requests for data should include the full name of the community or county and the Flood Insurance Rate Map panel numbers covered by the request. NOTE: The coordinate system used for the production of this Flood Insurance Rate Map (FIRM) is Universal Transverse Mercator (UTM), North American Datum of 1927 (NAD27), Clarke 1866 spheroid. Corner coordinates shown on the FIRM are in latitude and longitude referenced to the Universal Transverse Mercator projection, NAD27. Differences in the datum and spheroid used in the production of FIRMs for adjacent counties may result in slight positional differences in map features at the county boundaries. These differences do not affect the accuracy of the information shown on the FIRM.

ATTENTION: Flood elevations on this map are referenced to the National Geodetic Vertical Datum of 1929. These flood elevations must be compared to structure and ground elevations referenced to the same datum. BASE MAP SOURCE: Planimetric base map information was derived from multiple sources. The City of Myrtle Beach provided planimetric data based on 1950 aerial photography. The City of North Myrtle Beach also provided planimetric data. Additional information for the county was derived from U.S. Geological Survey 1:24,000 and 1:100,000 scale Digital Line Graphs and other sources. Users of this FIRM should be aware that minor adjustments may have been made to specific base map features.

 - ZONE A** No base flood elevations determined.
 - ZONE AE** Base flood elevations determined.
 - ZONE AH** Flood depths of 1 to 3 feet (usually areas of ponding); base flood elevations determined.
 - ZONE AO** Flood depths of 1 to 3 feet (usually sheet flow on sloping terrain); average depths determined. For areas of alluvial fan flooding, velocities also determined.
 - ZONE AV9** To be protected from 100-year flood by Federal flood protection system under construction; no base flood elevations determined.
 - ZONE V** Coastal flood with velocity hazard (wave action); no base flood elevations determined.
 - ZONE VE** Coastal flood with velocity hazard (wave action); base flood elevations determined.

 - ZONE D** Areas in which flood hazards are undetermined, but possible.

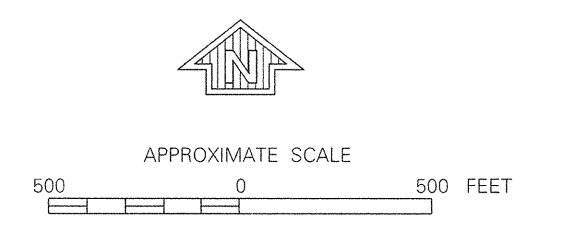

EFFECTIVE DATES OF REVISIONS TO THIS PANEL
 April 2, 1991 - to change zone designations and base flood elevations.
 September 3, 1992 - to incorporate Coastal Barrier Resources System areas and/or otherwise protected areas.
 June 16, 1994 - to increase base flood elevations, to change special flood hazard areas, to reflect updated topographic information and to add Coastal Barrier Resources System units.
 August 23, 1999 - to update corporate limits, to change base flood elevations and special flood hazard areas, to update map format, to add roads and road names, to incorporate previously issued letters of map revision and to modify Coastal Barrier Resources System units.
